**SPEAKER** : Group Leader-te atangin sawi duh kan awm em? Pu Zodintluanga Ralte, Member zahawm tak ka sawm e.

**PU ZODINTLUANGA RALTE** : Pu Speaker, waviinah Pu P.C. Zoram Sangliana leh Pu Andrew H. Thangliana te sunna hun kan han hmang tur hi a lungchhiatthlak ka ti a. A hmasain Pu P.C. Zoram Sangliana chungchang hi ka rawn sawi ang a.

Ani hi a mimal taka min duhsaktu leh min kaihruaitu a ni a, politics a ka luh tirh atanga awm dan mawi te, kal dan tha te min zirtirtu a ni. A hnung zui hian Mizoram dung leh vang ka fang chhuak a, motor-a kan chuannaah te thu tha tak tak leh kei naupang tea politics lut hi min kaihruaitu a ni tih kha ka han sawi hmasa duh a ni.

Tin, ani hi naupan lai atanga ram vei mi, a tak taka kan ramin hma a sawn theihna turin a rilru leh theihna zawng zawng a seng a. Zirlai anih lai khan rambuai kan ni a, kan ramin hma a sawn theihna tur atan remna leh muanna kan neih a ngai a ni tih hriain nasa takin hma a la a ni. Tin, nichina kan hriat tawh ang khan, kan ramah remna leh muanna a awm theihna turin hun rei tak jail-ah a tang a ni. Chumi hnuah remna leh muanna kan neih theihna tur atan Congress Party a rawn zawm a. Naupang te niin kan hotuten a potential-te, a thatna te leh a thiamnate hriaa ticket pein MLA-ah candidate-ah an dah a. Kum 1984-ah khan vanduaithlak takin khatih laia a khingpui PC Party Candidate, Pu Thawmvunga chu rawn taka a public meeting a nei lai kah hlum a ni a. Khatah khan election an nei thei ta lo a. Hemi ka rawn sawi chhuahna chhan chu Pu Speaker, amah hi mi duham lo, mi pamham lo leh ama tan ringawta ngaihtuah mi a ni lova. Kha inthlanah khan Congress Party khan chak takin sawrkarna an chang a, sawrkarna an chan tawh hnu khan vawiin ni ang tho hian by-election te hi chu ruling party ta tura ngaih a ni a. A duh phawt chuan candidate pawh, “hei hi chu ka ding leh tur a ni” ti sela tuma hnial loha MLA ni ve mai tur kha a ni. Amaherawhchu a inpekna leh a tlawmngaihate khan kan *senior*, inthlana tling ta lo kan hotu dang te kha a kian ta a ni.

Chhiatni thatniah kei, a naupang zawk leh ka chhungte damloh niah pawh tawngtai tura rawn kalin, Damdawi inah pawh a thleng hmasa ber a ni thei zel a; kan tluk lo khawp mai. Tin, khawtlanga inhmanna, YMA-ah te pawh Joint YMA President te niin, YMCA kan tih, NGO hrang hrangah pawh ‘tel lohna a nei lo’ ti ila ka sawi sual ka ring lo a ni.

Tin, kohhran lamah pawh a tlangval lai atangin an lawina kohranah pawh nihna pawimawh zawng zawng a chelh kim deuh vekin ka hria a, a hun tawp thlengin kohhranah nihna pawimawh tak a chelh a ni.

Tin, sports lamah pawh kan hria a, Football Association-ah patron niin, Hockey leh pawl hrang hrangah a inhmang a. Sport Minister anih lai khan thil tam tak kan ram hmasawmna tur a ti a ni. Chuvang chuan, Pu Speaker, Mizoram-in *mi bik, mi tlawmngai* kan chan ta hi a pawl ka ti a, a bik takin kan party tan chuan channa ropui tak a ni. A kalsan tak a chhungte Lalpa’n awmpui zel se tiin duhsakna ka rawn hlan a ni.

Tin, Member zahawm tak Pu Andrew H. Thangliana, ani pawh hi naupang te anih lai atanga inhria kan ni a, Shillong-ah lehkha zira kan awm laiin a pa hi Master Degree tiin Nongrim Hills-ah an chhungin an rawn awm ve a, chutih lai chuan naupang te a la ni a, chuta tang chuan kan lo hmelhriat tawh a ni. Aizawl-a kan rawn chuan chhuah leh hnuin veng khatah kan awm zui a, a pu Pu H. Thangliana phei chu kan family tana mi tangkai tak, kan sumdawmnaah pawh min kaihruaitu, sawrkar hnathawk a nih lai pawha harsatna kan neih leh kan hriatthiam lohte pawh min zirtira min tanpuitu thin tu an ni.

Zirna lamah chuan Pu Andrew hi lehkhathiam thei em em mai a ni a, politics-ah hun rei lote a awm chhung pawha hming chher ve hman, a hming chher dan pawh a bial, Tuirial Bial mipuitena an fak rawn em em mai a ni. Hetiang kan han chan hi a paw ka ti a. Future nei tha tak mai, kan ram tana nasa lehzuala hnathawk thei tur anih laia hun lo taka min kalsan hi a paw ka ti a. A kalsan tak a chhungte, a nupui fanau zawng zawngte Lalpa'n malsawmin awmpui zel turin duhsakna ka hlan nghal baw ka ni e. Ka lawm e, Pu Speaker.

**SPEAKER:** Member zahawm tak Pu Vanlalhlana i lo sawm leh ang.

**PU VANLALHLANA :** Pu Speaker, ka lawm e. Vawiinah hian member kal ta te, Pu PC Zoram Sangliana leh Pu Andrew Thangliana chanchin tawi tein ka han sawi ve ang a.

A hmasain Pu PC Zoram Sangliana hi kan hriat angin Saitual-ah a piang a, Matric thleng Saitual-ah a zir a. A hnuin Pachhunga College-ah a rawn zir zawm a, chutah chuan keini te nen hian kan intan tlangin kan inkawm tlang chho a, Students' Union Leader-te kan ni tlang a. Chuvangin, amah hi hrechiang ve thawkhatah ka inngai a. Pi Muani nen nen 1980-a an inneih pawh hian Saitual-ah a thian pakhata ding vein kan han kal a ni.

Pu Zoram Sangliana chanchin hi thlur liin a sawi theih a. Zirlai anih lai chanchin te, politics-a a chanchin te, khawtlanga a inhman dan chanchin te leh sakhuaa a inhman dan chanchin tein. A hmasa berin zirlai anih chungchang hi sawi ta ila.

Zirlai anih hun a pumpui thu hian Students Union Leader-in a awm a ni. Saitual-ah High School a kal laiin MZP hotuah a tang a, Pachhunga College-a a lo kal hian PU anih atanga BA a zir thlengin Students Union Leader zingah a tel tuan chhuak zak baw ka. Chumi hnu 1971, 1983-ah MZP General Headquarters-ah thleng Office Bearer a ni a, North Eastern Students Union, (Hmarchhak Students Union) ah pawh hruaitu ni reng thin a ni. Chuvangin a zirlai hun pumpui hi zirlai hruaitu niin hun a hmang a ni.

BA a zo chiah lo nain, 'pianpui BA' kan tih ang nihna hi a nei a, mi tam takina kan tluk loh a ni pha a ni. 1983-ah politics a zawm a, Congress Party a zawm a. Inkawmngaih viau mah ila ngaihndan inmil lo tak mai kan neih chu, ani hi nationalist a ni a, kei hi regionalist ka ni a, kan inhmin lo ve ve a ni. Congress Party-ah hian ka hriat theih chinah thalaiah te, District-ah te, Headquarters-ah te a inhman a, nihna chi hrang hrang a nei a ni. Kan ngaihthlak tawh angin MLA-ah vawi nga thlan tlin a ni a. Chu chuan mi chungchuan a nihzia te pawh a tilang awm e. Minister-te niin a hunlai hian World Record, *Cherawkan* hmangin min siampui a ni.

Pu Zoram Sangliana hi Pathian tih mi a ni a, rawngbawltu rinawm tak a ni. Salvation Army a ni a, a awmna apiangah rawngbawltu pawimawh tak a ni zel a. Kohhran rawngbawlna kan tihah hian sawmthum laiah a hun tawp thleng khan a tel a ni. Tin, Pu Ramsanga hi khawtlangah a inhman nasa em em a. Joint YMA-ah President-te niin, YMCA te leh Games & Sports lamah te pawh a inhman nasa em em a. Pawl (NGO) 27 laiah inhmanna a nei a ni.

Pu Ramsanga hi he House tizahawmtu leh hulumtu, Legislator kan neih zinga tha ber pawl niin ka hria a. Tum nga thlan tlin a ni hian Assembly-ah pawh hriat reng tlak hnuhma tam tak a hnutchhiah a ni. Min kalsan ta hi kan ui takzet a. A kalsan tak a chhungte zawng zawngte, a nupui fanaute leh a chhungte zawng zawng Pathianin awmpui se tih hi kan tawngtaina a ni e.

Tin, Pu Andrew Hmar Thangliana hi a chanchin tawi te ka han sawi leh ang a. Pu Andrew-a hi kan hriat angin a pa chu Pu Samuel Thangliana a ni a. October Ni 4, 1970-ah Aizawl Civil Hospital-ah a lo piang a, a naupan tet atangin naupang bawrsawm tak niin a thanglian chho a, kum 13 a nihin matric a pass a, a pass naupang hle a ni. Lehkha zirna lamah a tluang chho hle a, thiam pawh a thiam viau a, matric a pass hnu hian Kodaikanal-ah pawl 12 tha takin a zo a ni. Doctor nih tum a ni a, amaherawhchu a kumin a tlinloh avangin a zir ta lova. Tichuan, Delhi lamah zirin BA exam lai hian a damloh avangin exam pawh a titluantling thei ta lova, BA pawh a zo ta lova. Amaherawhchu, Business lampang certificate Delhi Business Administration Institute atangin a nei a ni.

Pu Andrew hi mi zakzum tak, rilru chak tak leh mite tanpui thin mi a ni a, mi chapo lo, khawngaihna ngah tak mi a ni bawk. Music a ngaina hle a, Mizo zingah chuan keyboard thiam hmasa pawl a ni awm e. Tin, rawngbawlina lamah pawh a kalna hle a, *Thlarau Thianglim Crusader Team*-ah telin ram chhung bakah ram pawn, England leh Ireland-ah te rawngbawlin a zin tawh bawk a ni. Kan hriat angin Pu Andrew hi mi hlemhle lo, mi duham lo tak a ni a, mi inzir mi tak, thil zir chak em em a ni a, kan Legislature Party tan pawh mi tangkai em em a ni.

Pu Andrew hi thangthar politician zingah chuan ram tana chhenfakawm tur pawla kan ngaih a ni a, a seat a ruak ta mai hi hriatthiam har kan ti hle a, kan khua a har hle mai a, a thihna hi ram tana hlohna nasa tak mai niin kan hria a ni. A nupui, a fate, a chhungte zawng zawng “Lalpa’n awmpui se” tih hi kan tawngtaina a ni e. Ka lawm e, Pu Speaker.

**SPEAKER :** Member zahawm tak Pu KT Rokhaw ka sawm ang a. Amaherawh chu *Zawhna & Chhanna* hun hi a la ve zel a ni tih kha ka han sawi zawk duh a ni e.

**PU K.T. ROKHAW :** Pu Speaker, ka lawm e. Pu Zoram Sangliana leh Pu Andrew H. Thangliana te *Sunna* hun kan han hmang ta mai hi pawl ka ti takzet a.

A hmasain Pu Zoram Sangliana chanchin, kan Chief Minister te, kan Opposition Leader te, kan MLA te khan chipchair deuhin anrawn sawi tawh na a, tlem han sawi ve leh ka duh chu, a nuna entawntlak, kei pawh ina ka lo experience tawh han sawilan ka duh a.

A kum chiah ka hre tawh lova, minister anih lai khan Siaha-ah alo zin a, circuit house-ah kan va hmu a. Chumi tum chuan nurethei te pakhat hian a lo hmu ve a, “Ka pu, ration buhfai khulna tur ka nei lova khawngaihmin pe thei ang em?” tiin arawn dil a. Tichuan, a thutna atangin room-ah a lut ta thut a, a zung lawk emaw kan ti a, mahse a lo chhuah khan a wallet phawrhin chu nu hnenah chuan, “Hei, ka wallet-a ka neih zawng zawnga note lian ber cheng zanga hi ka pe ang che” a ti a, cheng zanga note

a pe a ni. Pu Speaker, khang hun lai khan MLA te khan Rs. 5,000/- an hlawhin ka hria a, tichuan cheng zanga note khan buhfai quintal khat chu a lei thei zan a ni. Kha nu lawm lutuk kha a mittui te a tla hial a. Ka ngaihtuah a, kei ni ta ila, kha cheng zanga note kha ka pek phal ka ring lo. Chuvang chuan, Pu Zoram Sangliana hi, hmeithaite, miretheite, miharsate leh dai kil kara mite dinhmun hrechiangtu a ni a, chutiang mite hmangaih em emtu a ni tih a lan chian em avangin leh chu chu a nuna entawntlak anihna lai kha ka han sawi lang ni se.

Tin, Pu Zoram Sangliana hi Congress party leader hlun, MLA pawh term nga lai lo tling tawhin, minister te pawh lo ni hial tawh a ni. Tun term-ah pawh khan Minister a ni chungin party ticket a chang zo ta lova, chuti chung chuan Congress party-a mi rinawm tak a ni zui a ni. Tun term election-ah pawh khan *Star Campaigner* a ni a, ka bial Palak-ah pawh min lo campaign-pui hial a, chutianga mi rinawm leh entawntlak chu a ni. Keini, a bik takin chhim lam, Lai, Mara leh Chakma te hi chuan kan leader bikah kan ngai a ni tih kha ka han sawi duh bawk a. Amah kan chan ta hi Mizoram tan channa nasa tak a ni.

Tin, Pu Andrew H. Thangliana hi naupang te niin MLA-a thlan tlin a ni a, a term pawh hmang zo lovin hetiang hian a lo boral ta a ni. A nupui leh fate ka tuarpui takzet a ni tih kha ka han sawi duh bawk a ni e. Ka lawm e, Pu Speaker.

**SPEAKER** : Minister zahawm tak Pu Lalruatkima ka sawm e.

**PU LALRUATKIMA, MINISTER** : Pu Speaker, ka lawm e. Vawiinah he House zahawm tak hian member lo ni tawh mi pahnih *Sunna* hun kan han hmang mek a ni a. A hmasain, tum nga zet mai MLA atana thlantlin ni tawh Pu PC Zoram Sangliana chanchinin ka tan ang a. A chanchin ngaihnawm tak mai, kan House leader te, kan member zahawm tak-te atangin kan ngaithla a.

Ani hi kan hriat angin, mi thilphal, *Pathian tih mi* a ni a. A chanchin hi sawi tur tam tak awmin ka hria a, bial khat kan nih bakah veng khata khawsa tlang kan ni a. pawhin GST hi kan zir vekin ka hria a, kan duh dan ang chu a nilo tih chu kan chiang a ni. Amaherawhchu *uniformity* a awm theihna tura hetiang a an rawn tih si chuan, kan duh loh lai emaw kan duh lai emaw han rawt viau tur chuan harsatna chin chu a awm a ni. **PU ZORAMTHANGA, CHIEF MINISTER :** Pu Speaker, ka lawm e. A tira ka sawi kha chu House-in kan discuss theih nan a *ruangam pui* ka rawn phawrh chauh a ni a. Han sawi vak dawn khan a copy kan nei vek a, “hei hi hei hian thlak ni se, hei chu paih ni se, hei hi chu hei zawk hian” tih kha a ni mai a. Chuvangin a tlangpui thu kha a ni a, House-in kan sawi khawmna tura a hmawr ka rawn hawngah ka ngai a. Tin, a hmawr kan hawn bakah han sawi dawn hian kan member zahawm tak ten a an sawi ang khan pass lo thei dinhmunah pawh kan ding lova. Central-in min rawn tuk ve, India ram zawng zawngin a kan neih tlan tur, Session hmasa berah lo pass hram tura an tih kan nih avangin kawng dang vak pawh a awm lova.

Amaherawhchu a tlangpui kan han inhrilhfiyah thuk thuk a, detail zawk chuan ka sawi ang khan a *original*, heta a Dan pui ber copy lian tak kha a hma daih atangin kan nei tawh a. Tin, a siamthatna tur nichina kan sawi ang khan a hma daiha tangin min pe vek a, kan ching kan ching tawh a, kha kha kan member zahawmtak ten in neih vek

tawh, han chhiar chhuah leh vel kha hun a hek mai mai e tih avangin, a *text* kha chu ka rawn chhiar chhuak lova, a inthlak dan, “hei hian hei hi a thlak a ni; hei hi chu paih a ngai a ni” tih te, Central-in a rawn rawtna anga tuna kan *amend* dan tur kha ka rawn chhawp chhuak a ni.

Kan sawi tak ang khan July Ni 1, 2017 atang khan Goods & Services Tax hi hman tan a ni a, tichuan central-ah te, State leh UT-ah te mahni thuneihna huam chung theuha hman tura duan a ni a.

Tin, central sorkar hian Goods & Services Tax Act, 2017 hi a keng kawh a, State leh UT zawng zawng ten Goods & Services Tax Act, 2017 chu mahni thuneihna huam chung theuhah an keng kawh ve thung a. A tlangpuiin a kalphung a in ang vek a, Mizoram-ah pawh State leh UT dangte rualin he amendment hi 2017-a kan neih sa siamthatna tur central-in a rawn chhawp kha min rawn pe a, chu chu tuna kan han en tlan hi siamthat tura kan rawn rawtna a ni.

Tichuan, he Mizoram Goods & Services Tax Amendment tak hi Finance Act, 2021 India President-in March Ni 28-ah a lo pawmpui tawh a ni a, chu chuan Central Goods & Services Act, 2017-a amendment 14 siamthat tur a siam a, a zulzui hian GST Council chuan state tin te hnenah mahni state bilin GST Act chu amendment siam turin a rawn ti a. Chutiang chuan Legislative assembly session neih hmasak berah pawh pass tura min hrilh angin kan han phawrh ta a ni.

Hengah hian section 13 a awm a, sub-section te nen chuan 14 angin a sawi theih a. GST Act hrim hrimah hian section 168 hi amend ni mahse state GST Act-ah chuan amend a ngai ve lo thung a. Amaherawhchu, amend tura kan han tih, nichina kan han sawi takah khan section 7-na in a han tiha kha chu supply chungchang thua a siam thatna tur a ni. Section 16-na ah kha chuan a tax ‘credit input’ claim dan tur *condition* leh *eligibility* chungchang thu kha a ni.

Tin, Section 35-naah khan ‘Account leh Records’ dang chungchang thua siamthat ngai lai tha zawka an hriat chungchang thu an rawn ti bawk a. Tin, section 44-na khan ‘Annual Return’ chungchang an rawn sawi a. Section 50-naah khan ‘tax pay delay’ avanga a *interest* kalpui dan tur a rawn sawi bawk a ni. Section 74-naah khan, “determination of tax not paid or short paid or erroneously refunded or input tax credit wrongly availed or utilized by reason of fraud or any willfully statement or suppression of facts” a ti a, chung ho siamthatna atana section 74-na kha duan a ni. Section 75-naah kha chuan tax kan determine dan tur *general provision* a rawn sawi a, Section 83-naah khan case thenkhata *revenue protect* dan tur provision kha a rawn sawi leh a.

Tin, Section 107-naah khan *appellate authority*-a appeal dan tur siam danglamna a rawn sawi leh a. Tin, Section 129-naah khan *detention* chungchang bakah *goods* leh *conveyance transit*, (phur kual velna) chungchanga man theihna dan leh a release theihna dan leh detain dan a rawn sawi leh a. Tin, section 130-naah khan *penalty* chungchang, bungrua man leh a phurhna dan, *confiscation* chungchang thu a rawn sawi leh a. Tin, Section 151-naah khan *statistics collection* atana thuneihna (power) pekna chungchang thu kan amendment-ah khan a rawn sawi bawk a. Tin, Section 152-naah hian *information* chungchang thua sawi tur leh sawiloh tur chin, public-a puan tur leh

puanloh tur chin te nen lam ‘*bar on disclosure of information*’ chungchang a rawn sawi a.

Tichuan, heng hi section tin a tlangpuia kalpui kha a ni a, engti chiahin nge a danglam tih chu a copy kan nei vek a han chhiar chhuah leh pawh kha a ngai chuang lova, a tam ang reng si a. Kha kha a tlangpuia ka zuk sawi chu a ni.

Tin, khawvel pum huapa kan buaipui Covid-in kan sumdawwna kawngah harsatna nasa tak min siam a, chung kan harsatnate min hriatthiampui tur leh min ngaihnhathiampui tura kan dil angin GST Council chuan kawng hrang hrangin a *relax* ta a, chu chu hetah hian an rawn telhna a ni a. Hei hian sumdawngte harsatna pawh nasa takin a sut kian sak theih kan beisei a ni.

Tichuan, hetiang karah hian Taxation Department pawhin theih tawp chhuahin tan a la a, kumin Financial Year (April - August) thla 5 chhung khan tax hmuh tawh hi vaibelchhe 350.74 a ni a, kum khatah hemi ang rate-a an kal theih chuan vaibelchhe 700 leh 800 inkar chu keimahni ram chhungah tax pawh kan hmu ve theih a rinawm a. Boruak a lo ziaawm phei chuan hei aia tam pawh kan hmuh theih kan ring a ni. Tin, department hian target a neih pawh a khum tha khawp mai a, chuvangin Taxation department hi Covid avanga hriatthiamna tura amendment central-in an rawn tih, keiniin kan lo pass leh turah pawh hian hengte hmang hian nakinah department-in hma a han la ang a, a ni lo berah pawh vaibelchhe 700 atanga 800 chho vel a hmu turah ngai ilar, chu chuan kan harsatna pawh nasa takin min sut kian sak kan beisei a ni.

Engpawh ni se, he rules *notify* tur hi tam fe a awm a, central lamin a rawn tih tur te, keini lamin kan tih tur, keimahni state ina kan notify tur te pawh a awm a. Amaherawhchu central tih tur hi a tam a, *notification 20* lai siam tur a nei a, state ina kan tih tur hi chu 5 emaw lek a ni.

Tichuan, Pu Speaker, tuna ka han sawi ang khan Covid-in min tihbuaina te, tin, 2017 atang khan kum tam a lo liam ta a, hei hi India ramin development lo thang zeal Goods & Services Tax kan hman dan te; kan thil phur intawlh kual dante thlaka, tunah phei chuan internet system khawvelah kan kal tak avanga tihdanglam ngai tam tak te; tin, a pawimawh berah chuan Covid-in min tihbuai hun chhunga kan tih theihloh inhriatthiamna tur te, chung atana keimahni pawh kan in adjust dan turte ngaihtuah chungin he Goods & Services Tax (Amendment) Bill hi rawn siam leh rawn put luh a ni. Kan ram tan pawh a thawktute’n an thawh nana tangkai leh tha nia an hriat angin an lo siam fel a. Tin, Dy. Chief Minister-in a sawi ang khan, pawisa ngaihbelh tur chi pawh a ni lova, tam tak a thawhchhuah belh zawk kan ring a. Chuvangin, he House zahawm tak hian, ‘Mizoram Goods & Services Tax (Amendment) Bill, 2021’ hi kan ram tana thil mamawh, thil tul leh tangkai tak a nih avangin lungrual taka min pass pui turin ka dil a ni e. Ka lawm e.
