Chutiang chuan Ground Water Operation hi department-in theih tawp chhuahin a buaipui dawn a ni tih kha ka sawi duh a.

PU ZODINTLUANGA RALTE: Pu Speaker, Mizoram kaltlanga kuhva rawn lut hi Mizoram ti ti a ni a, kan social life a khawih nasa em em a, khawchhak lam zin nan pawh, motor lian tam lutuk avanga zin hleih theih lohte, kawngpui a ti chhia tihte leh kan Champhai leilet hmunte pawh godown atan tha hnem tak hman chhoh anih mek thu te kan lo hre thin a. Tin, chumi piah lamah khaw hrang hrangah kawng laiin Tiau kam atangin Burma ramah kawng laih chawpin an rawn luh chhohna te an sial a. Kan environment tam tak a ti chhe bawk ani tih te hi kan hria a.

thute kan lo hria a. Chutiang anih avang chuan, Pu Speaker, ka zawhna chu- Khawchhak atang Mizoram kaltlanga kuhva rah sumdawnna hi Mizoram sorkar hian chhiah a la anih chuan dan anga sumdawn naah a ngai tihna em ni?

Tin, Assam Rifles te hian kuhva rah sumdawnngte atangin chhiah an la ve em? La ni se sorkar laipuah engzat nge an chhunluh tawh tih min hrilh theih chuan ka lawm ang a.

Tin, a pathumnaah, Malaysia leh Indonesia atanga lak kha Mizoram tharchhuah angin MAMCO-in certificate diklo an siam sak a, phailamah an thawn chhuak tihte hi thudik a ni em, tihte hi kan Minister zahawm tak hian min hrilh thei se.

SPEAKER : Zawhbelhna zawt turin Member zahawm tak Dr. ZR Thiamsanga i lo sawm ang.

DR. ZR. THIAM SANGA : Pu Speaker, ka lawm e. Ka zawh belhna, hon. Minster, Taxation Department chhan atan, Starred Question No. 30-na hi a chhuak hman dawnlo in ka hria a, hei hi kan Minister chhan tur tho a nih avangin a in persan deuh naa kan zawt e – Champhai-ah Taxation Department staff quarters sa turin hma min laksak thei em? Champhai hi kan hriat angin district ah pawh a lian pawl ve tak, sumdawnna pawh tha tak a ni a, chuvang chuanin staff pawh engemaw zat an awm a, GST leh engkim an khawih a. Staff quarter a awmlah avangin a buaithlak hle a, kan Minister zahawm tak hian staff quarter sa turin hma min laksak thei ang em? Ka lawm e.

SPEAKER : Zawhbelhna zawt turin Member zahawm tak Pu Lalsawivunga i lo sawm leh ang.

PU C. LALSAWIVUNGA : Pu Speaker, ka lawm e. Taxation Minister zahawm tak chhan atana ka zawh belhna te chu –

Kum 2020-2021 financial year chhung hian Myanmar atanga bungrua lo lut atanga GST lak tlingkhawm engzatnge tih hi ka zawhna pakhatna a ni a. Myanmar atanga bungraw lo kal hi Zokhawthar a lo luhin Custom-in *import charge* an la a. Tin, Zokhawthar-ah vek hian sorkar Police leh Assam Rifle ten pawisa an chawitir ve leh tho niin a lang a. Tin, Champhai Land Custom Prevention Force ten an la bawk a. Tin, Champhai hnuai a awm tho Kawlkulh-ah lak a ni leh a, Seling-ah lak a ni leh bawk a. Tin, Champhai-ah GST lak a ni a, Keifang-ah lak a ni leh bawk a. Pu Speaker, Myanmar atanga bungraw lo kalah GST sumdawnng mite hnena lak anih rau rau chuan sorkar hian mumal deuh zawkin a kalpui thein ang em tih hi ka zawhbelhna pahnihna a ni e.

SPEAKER : Awle, zawhna kha Taxation Department chan ni lo custom leh AR chungchangte a ni a. A hrang nuaih mai a, a theih ang anga chhang turin a changtu Minister zahawm tak Pu Lalchamliana ka sawm e.

PU LALCHAMLIANA, MINISTER: Pu Speaker, Zawhna neitu Member zahawm tak Pu Zodintluanga'n, kuhvaa sumdawna mizo mipuiten kan buaipui a, kan social life a khawih nasa a ni tih kha keipawh ka hriat dan a ni. Champhai chheh velah chuan kan official ten sawi dan chuan, zanah kuhva hi an load deuh ber a, mi pakhatin zan khatah ₹3000-5000 an hlawh thei a ni tih thawmte kan hria a ni.

Tin, Zokhawthar-ah formal trade official-a a awm loh avangin kuhva lo luh nan hian JCB-te an hire a, Tiau an pawh tir a, ral lehlamah chutiangan an ti bawh a, pick-up in an thiar a Champhai-ah a lut reng a ni tih hi kan hriat ve dan a ni a. Thalai tam takin an zirlai ngaihsak tawh lovin khatiang inhlawhna tha tak lo awm ta kha an bawhzui a. Nakin lawkah chuan society-ah harsatna a thlen thei ang tihte an sawi a ni.

Chumi kan hriat hma chuan, nikum October/November vel khan kuhva sumdawng pathum an awm an ti a, chungte chuan kan hotu hrang hrangte leh keipawh min rawn dawr a, kuhva tangkhang hi min chhuah sak teh u a, an ti a, an khawngaithlak hle a ni. Tichuan, Dan ni chiah lo, Dan hrulah, India sorkar-in kuhva ro kg 1-ah GST 5% lak tur a tih angin in i chhut ang, kan ti a. Tichuan, a awmsa clear-na turin hun siam ang kan ti a. GST-a in register ten e-Way Bill an siam a, Custom-ah leh Assam Rifle-ah pawh an tlang phah theih nan kan ti a, kan police-ten kan mit kan siai a ni. Mahse chu chu advantage-ah lain tunhnai thlang khan Burma atangin kuhva hi a la lut reng tih kan hria a. Chuvang chuan meeting-ah uluk takin kan sawi a, "Hei hi India sorkar-in vawi 3/4 lai lekhathawnin titawp tura min rawn request angin, titawp tur zawngin hma lak a ngai a nih hi kan ti a.

Champhaiah gate a awm pawhin Hnahlan lamah an hel a, kawng hrang hrangin Saitual-ah te an rawn lut a. Chutiangan chuan nasa takin an bei a ni. Amaherawhchu tuna kan ngaihtuahnaah chuan, heng kuhva ro hi *smuggled goods* a ni lova, a thiangan ni, mahse ram dang atanga lak luh a nih chuan *illegal goods* a lo ni ta a. Champhai bial leh East Tuipui bialahte kuhva an ching tih kan hre si lova, Burma atanga rawn lut a ni ang tih a rinhlehawm em em a ni.

Chuvang chuan, tan kan la ang a, engemaw kan theih loh ang le, tiin tunah hian Police Headquarters-in Silchar kawngah duty point siamin, khulama lut thla tur khu chu dang phawt turin inbuatsaihna a kal mek a ni tih ka sawi duh a ni.

Tin, 'Assam Rifles nge thu Mizoram sorkar' tih kha kan thuna chin a in ang lo deuh ang chu. Assam Rifles hi Mizoram sorkar control an ni lova, Union Home Ministry-in direct-a a control a ni a. check post an siamnate hi *free movement regime* km 10 chhungah duh chuan an siam ang an ti tur a ni. Chuvang chuan, Mizoram sorkar leh Assam Rifles thuneitute hi kan intauh thin a, a chang chuan Seling bulah an lo check ve ringawt a, nasa takin kan object thin a ni. Tin, MAMCO-in cetificate lem a pe em tih zawhna kha, keini Taxation Dept. atang chuan kan hriatpui hauh lo mai tih kha ka chhanna a ni.

PU ZODINTLUANGA RALTE: Pu Speaker, kan Minister khan Champhai atanga kuhva rawn lut hi sorkar angin decision siam tawh niin, tihtawp a ni dawn tih kha min chhanna final a ni em?

PU LALCHAMLIANA, MINISTER: Kha kha chu final leh final loh a ni a, hma kan han la phawt ang chu. (*Pu ZODINTLUANGA RALTE: Thutlukna in la siam lo nge in la ingaihtuah mek?*) Kan inbuatsaih mek a ni.

PU ZODINTLUANGA RALTE: Chuti chu *illegal goods* ni reng si kha sorkar hian, 'he thil hi a dik lova, chutichung chuan hei leh chen hi kan hmu tawh a, kan titawp dawn e,' ti lovin, 'kan la ngaihtuah dawn mek e' a tihna a ni maw?

PU LALCHAMLIANA, MINISTER: Hma kan la mek a ni. Tin, ka sawi tawh ang khan kuhva hrim hrim hi *illegal goods* a ni lova, amaherawhchu *smuggled goods* a nih chuan *illegal* a lo ni ta a. Champhai vela a lo luh chuan khilaiah an ching si lova a rinhlehawm em em ani tih ka sawi a ni. Chu chu kan enzui mek a, hma kan la mek a ni.

SPEAKER : Kan zawhna siamah hian social media a chhuak leh tur hi kan khel lutuk thin a, fim taka sawia, eng emaw inkam hi kan ching a, hei hi tun hnaia thil chhuak thar a ni a, a tha lo khawp mai. Chhunzawm rawh le.

PU LALCHAMLIANA, MINISTER: Pu Speaker, AR-in chhiah an la em, engzatnge an lak tih kha, AR-in an lak leh lak loh hi keini chuan kan hriatpui lova. Tin, Member zahawm tak Pu Thiamsanga'n Champhai Taxation staff quarter a chhe khawp mai a tih kha a dik a. Ka department chan hi a ni bik em aw ka ti a, khawi hmunah pawh hian Police Quarter-te pawh a chhe em em deuh vek a, Pu Nihar pawh hian a bial chhunga mi hi a sawi thin a. Amaherawhchu, tun dinhmunah chuan Champhai-ah hian staff quarter sak tumna kan nei rih lo tih kha ka chhanna a ni e.

PU C. NGUNLIANCHUNGA: Siam that theih lai a amend tur thlir daih te chu, tunah hian kha kha chu thlak mai ila a har chuang lo a. Tin, Dan siam dan, a spirit, a kalphung a ni bawk a, khalaia kha chu support zawngin phar lo mai ang.

SPEAKER : Awle, khalai kha a awmzia bill neituin a rawn sawi a. Tin, bill reng reng hi helaiah a hminga ministerte, sorkar a nih takah chuan nu leh pa chan changa khawi area ah emaw, khawi maw lai ram bik sah thlak ang rilru a awm a thiang lova. Chuvang chuang “It shall extend to the whole of Mizoram,”, Mizoram pumpui a huam e, tih khan tute emaw tan a lo ngaih huat theih a, “Tiang hian min sat thla nghal reng alawm le!” tih a awm lohna turin pa chan chang takin, “Mizoram pumpuia tana hman tur a ni e” tiin bill-ah a rawn lut kha a ni a.

Nichin khan ka lo ngaithla a, “Remti” ti kha mi 40 dawn in ni a, “Remti lo” ti kha 1 a ni a. “Remti” tih kha a tam zawk avangin leh “Remti lo” pakhat chauhin a tih avangin, “The Mizoram Licensing and Regulation of Private Veterinary Hospitals and Clinics Bill, 2021” chu he House hian a passed ta a ni.
