S.O. 6148(E).—In pursuance of the provisions of Schedule I to the National Food Security Act, 2013 (20 of 2013), the Central Government hereby decides that the rice, wheat and coarse grains shall be provided free of cost for all eligible households under section 3 of the National Food Security Act, 2013, for the period 1st of January, 2023 to 31st of December, 2023.

Provided that the prices of foodgrains for benefits under section 4, 5 & 6 of the National Food Security Act, 2013 shall continue as per notification S.O. 3546(E) dated 30th September, 2019, until further orders.
