**MEMORANDUM OF AGREEMENT (MOA)**

THIS AGREEMENT is made on this 17<sup>th</sup> day of January (month), 2024 between the Governor of Mizoram represented by the Secretary, Animal Husbandry & Veterinary Department, Government of Mizoram, hereafter referred to as First Party;

AND

Mr. V. Malsawmdawngliana, a resident of Chanmari, Aizawl, hereafter referred to as Second Party;

First Party and Second Party are individually referred to as "Party" and collectively as the "Parties";

WHEREAS to make available of good quality Livestock & Poultry Feed and ingredients by minimizing the huge transportation cost incurred during road transportation by using railway transport is considered necessary;

AND WHEREAS the main goal is to procure ingredients of feeds, process as quality feeds as well as finished products from mainland India to bring down the cost of per kilogram of finished product feed which will subsequently reduce the cost of meat and its end product., First Party has initiated an 'Establishment of Animal Feed Plant at Lengpui, Mizoram' under RIDF-XXVIII Tranche (NABARD).

AND WHEREAS Second Party has agreed to manage and run the business involving Animal Feed production at Lengpui in coordination with First Party and carry out its responsibilities;

AND WHEREAS the Second Party has to operate and maintain the Animal Feed Plant on their own available vacant land themselves at Lengpui under Public- Private Partnership (PPP) through transparent Concession Agreement by Second Party to repair/retrofit, develop, operate and maintain the




infrastructures under the project for a period of 19 years starting from 6 months after successful implementation of the project which may be extendable with the approval of the First Party.

AND WHEREAS in pursuance of the aforesaid, the parties hereto wish to record under this Memorandum of Agreement (MoA), the terms of their understanding in order to implement the project entitled "ESTABLISHMENT OF ANIMAL FEED PLANT AT LENGPUI, MIZORAM";

NOW THEREFORE THE PARTIES WITNESSED AS FOLLOWS:

1. That both parties mutually agreed that the First Party shall be the Nodal Agency whereas the Second Party shall be the Implementing Agency, bearing power of Attorney of the other party for operation, maintenance, and management of the Infrastructures under the project at Lengpui.
2. The Animal feed business shall be administered by Second Party and will have rights to produce and sell animal feed ingredients and end products in open market at cost to recoup his investment. However, a duly constituted Board of an appropriate level will ascertain the reasonableness of rate for sale of animal feed and the ingredients on each occasion. The decision of the Board shall be binding and final.
3. That Second Party agreed to maintain book of account and furnish to audit as and when called for.
4. That project activities and the expenditure thereon will be at the responsibility of the Second Party. Any legal or tax related issues from a third party arising out of this agreement should be dealt by the second party.
5. That the Second Party will arrange and pay for machineries, equipment, manpower, slips, etc.



6. That the Second Party will submit periodical reports on Plan of action to the First Party.
7. That First Party privileges the right to receive 10% of the net profit earned by the Second Party as share of profit annually. The First Party will have rights to review and revise the rate of revenue sharing and the net profit share on mutual concept.
8. The Second Party share of profit may be credited to Government account through First Party after 6 months of successful implementation of the project which included Infrastructure development and installation of Equipments and Machinery.
9. That Second Party for the purpose of effective implementation of the project entitled "Establishment of Animal Feed Plant at Lengpui, Mizoram" shall provide:
  - a. The details of available land under their property which is being offered for the project:
    - i. under the name of V. Samuel Nunhlua s/o V.Malsawmdawngliana, LSC No.29 of 2000 (Lengpui), LSC No.36 of 2000 (Lengpui), LSC No.46 of 2000 (Lengpui), LSC No.54 of 2000 (Lengpui), LSC No.55 of 2000 (Lengpui), LSC No.57 of 2000 (Lengpui);
    - ii. under the name of Lucy Vanlalhlani w/o V.Malsawmdawngliana, LSC No.35 of 2000 (Lengpui), LSC No.38 of 2000 (Lengpui), LSC No.39 of 2000 (Lengpui), LSC No.49 of 2000 (Lengpui), LSC No.53 of 2000 (Lengpui), LSC No.41 of 2000 (Lengpui), LSC No.28 of 2000 (Lengpui);
    - iii. under the name of V.Malsawmdawngliana, LSC No.27 of 2000 (Lengpui), LSC No.33 of 2000 (Lengpui), LSC No.34 of 2000 (Lengpui), LSC No.30 of 2000 (Lengpui), LSC No.37 of 2000 (Lengpui), LSC No.45 of 2000 (Lengpui), LSC No.50 of 2000 (Lengpui)
  - b. Necessary statutory approvals for construction through single window system, within 30 days;
  - c. Trunk infrastructure facilities (e.g. roads and services, water, drainage etc.) upto project site;
  - d. Municipal service charges such as water supply, electricity, house/property tax, etc. levied at par with the residential properties.
  - e. The First Party will maintain a separate budget account for keeping of the funds deposited by the Second Party, to be further deposited to the State Government's consolidated fund for promotion of projects of the same nature.




- f. That both parties agreed that the Second Party will maintain a separate account for the project, along with a separate book of accounts to be Audited annually by Charter Accountant. The audited reports should be submitted to the First Party.
- 10. That both parties to the agreement further covenant that in case of a dispute between the parties, the matter will be resolved through mutual discussion.
- 11. Any circumstances beyond the control of the Second Party or the First Party as the case may be which cannot be foreseen and which substantially affect the performance shall be dealt with conducive atmosphere.
- 12. Any legal dispute litigation arising out of the terms and conditions of the agreement, the Court of Law at Aizawl shall have the jurisdiction to adjudicate the same.
- 13. The First Party reserve the right to terminate the agreement if the Second Party fails to fulfill the terms of this agreement. Pre-requisite terms of this agreement are a written notice by the First party to the Second Party to abide by the terms and conditions of this agreement clearly specify the default of the Second Party.


