PRELIMINARY NOTIFICATION

**FOR LAND ACQUISITION IN SIHPHIR, AIZAWL DISTRICT FOR
INDIAN AIR FORCE (MPR)**

WHEREAS, it appears to the Government of Mizoram that land described in the Schedule shown below is proposed to be acquired for establishment of Indian Air Force (MPR) under the Ministry of Defence, Government of India, for maintenance of national security as per the Gol letter No. 13021/12/2023/US (L-1) dated 05 May 2025 issued by Hon'ble President of India.

AND WHEREAS, land is required for the project under the Right to Fair Compensation and Transparency in Land Acquisition, Rehabilitation and Resettlement Act, 2013 (hereinafter called the RFCTLARR Act, 2013).

AND WHEREAS, the recommendation for exemption of Social Impact Assessment (SIA) study by the District Collector of Aizawl District was approved by Competent Authority/Hon'ble Minister of State, Land Revenue & Settlement Department on dated 15th May, 2025 under Section 9 of the said Act (Read with Section 40 (2) of the Act)

Now, therefore, the Government of Mizoram under **Section 11** of the RFCTLARR Act, 2013 hereby notifies that-

1. The said land is likely to be needed for the purpose specified above ;
2. The Deputy Commissioner/District Collector of Aizawl District shall conduct Preliminary Survey of the land for the said project so as to acquire the minimum area required for the project, if not already done, as provided under section 12 of the said Act, and shall also update all records of lands within the land to be acquired **within fifteen days (15)** from the date of publication of this Notification, prior to publication of declaration by the Government.
3. The acquisition of the said land is **exempted from undertaking of the Social Impact Assessment Study** as provided under Section 9 of the Act (Read with Section 40 of the Act);
4. Any person interested in any land within the notified area may file his or her objection to the Collector **within fifteen days** Considering the land does not require any social impact assessment/resettlement, area being barren land and undisputed from the date of publication of this notification as provided under Section 15 of the said Acts as regards –
 - (a) The area and suitability of land proposed to be acquired.
 - (b) Justification offered for public purpose.
5. The Additional Deputy Commissioner, Aizawl District is appointed as **Administrator** for the purpose of rehabilitation and resettlement of the affected families if any, as provided vide Notification No.H.11018/3/2025-REV dated 07.05.2025

6. No new allotment of land or nature of land rights shall be made within the affected area by authorities concerned after the date of publication of this notification.
7. Persons interested in the said land are hereby warned not to obstruct or interfere with any Surveyor or other persons employed for the purpose of the said acquisition. Any contract for the disposal of land by sale, lease, mortgage, assign change of the status of Pass or otherwise or any outlay commenced or improvement made therein after the date of publication, without the sanction of the Collector will, under sub-section (4) of section 11 of the Act, be disregarded while assessing compensation for such parts of the said land as may be finally acquired.


